A MESSAGE FROM DAVID THOMPSON

Chairman of our Management Committee

The well-publicised problems of the Maxwell Group pension schemes must have alarmed many pensioners in this country, so I am especially pleased to have this opportunity to reassure all of you about the security of our own Scheme, which has the following built-in safeguards:

- Our nine Trustees include four directly-elected member representatives, one of whom is chosen by the pensioners. All the Trustees receive thorough training (see back page for more on this).
- We take independent expert external advice on our investment policy, which can be altered only with the agreement of the Trustees.
- Our investment managers are appointed by the Trustees and are totally independent of the Company. Their performance is monitored by an independent agency.
- The Rules of the Pension Scheme prohibit both stock-lending and any form of investment in Rank Xerox.
- The assets of the Scheme are held securely on behalf of the Trustees by an independent master custodian.
- The Scheme's banking arrangements are quite separate from those of the Company and strict procedures must be observed for authorising transfers of cash and assets.
- The Scheme's accounts are audited each year by professional external auditors who have commented regularly on our high standard of accounting and internal control procedures.

I hope that this information will reassure all our pensioners and inspire a fully-justified confidence in the security of the Scheme which provides you with your pension.

Golden Anniversary

At the end of last year, the village of Mitcheldean celebrated its 50-year relationship with Rank Xerox. This golden anniversary was marked, appropriately enough, by a presentation by the Company of a gold chain of office to be worn by the chairman of the Mitcheldean Parish Council.

It was in 1940 that The British Acoustic Film Company (BAF), later to become Rank Precision Industries, evacuated war-torn London and took over the old Forest Brewery building at Mitcheldean, bringing employment and new-found prosperity to this sleepy Forest of Dean village.

The signing of an agreement between the Rank Organisation and the Haloid Company of America and the formation of a new company, Rank Xerox, to exploit the revolutionary "dry copier" technology marked the beginning of Mitcheldean's most rapid industrial development. From 1960, when the first 914 copier was produced on the site, to the end of the 1970's, Mitcheldean saw virtually uninterrupted expansion and a steady growth of the workforce to a peak of 5,000 people.

The early 1980's brought a

period of retrenchment when the loss of xerographic patents and intense competition resulted in reduced market share, but successful rationalisation meant that the Mitcheldean plant was soon fighting back. With the recent transfer to the site of electronics manufacturing, Mitcheldean is now the sole UK manufacturing operation for Rank Xerox and employs around 2,000 people. A further 800 are employed by other businesses on the site.

DISCRIMINATING ON ABILITY

In a new policy statement, Rank Xerox has reaffirmed its commitment to equality of opportunity, summed up in the slogan "We only discriminate on ability". The Company's aim is to ensure that, in all aspects of employment, a person is judged solely on the basis of ability, without regard to race, sex, religion, age or disability.

In charge of the Equal
Opportunities Programme is Viki
Ford who is keen to dispel any idea
that the Company is jumping on
the bandwagon. "We're not just
paying lip service to the idea of
equality of opportunity - we have seen
where we want to be and a long-term
strategy has been put in place to get us
there. To tap into the widest pool of
talent, we must create a work
environment that attracts the brightest
and best from all sections of society."

A series of Equal Opportunity workshops has already been held throughout the Company to increase awareness and the Company has also been

Back in 1940, as a 15-year old, Les was working for the local firm which was responsible for preparing the old brewery site for the arrival of its new BAF tenants. Recruited by BAF the following year, Les was one of the first local people to be taken on at the site and worked there for 40 years until his retirement in 1981.


meetings to be held without having to move off-site at all.



Prince of Wales Announces Training Award

The Award - the training world's equivalent of the Queen's Awards for Export and Technology - was announced by the Prince of Wales at a ceremony in London and presented to Mitcheldean managers, Kevin Horrobin and Brian Fowler, at a subsequent ceremony in Cheltenham organised by the Gloucestershire Training and Enterprise Council.

PACKAGING GOES GREEN!

JACK MILLIGAN APPOINTED VICE PRESIDENT

Jack Milligan has been elected a vice president of Xerox Corporation and has taken over responsibility for Xerox financial relations with Fuji Xerox. Before taking on his new job, where he will be a key adviser to Xerox Chairman, Paul Allaire, and senior management on Fuji Xerox matters, Jack Milligan was Director, Finance and Control, for Rank Xerox Ltd.

As we reported in the last issue of the Newsletter, Rank Xerox is turning steadily "green"! An important part of the Company's environmental policy over the past two years has been the development of new packaging materials to provide environmentally-acceptable alternatives to the expanded polystyrene widely used in the past. Now the packaging of Rank Xerox products is very nearly 100 per cent "green".

The main challenge for the 11-man Quality Improvement Team headed by Packaging and Distribution Engineering Manager, Bill Starkey, was to find a cushioning material which would do the job of protecting the Company's products but would not have the disposal problems associated with expanded polystyrene.

For heavy products, the team came up with Corrupad, a cushioning material made out of layers of corrugated board glued together and then cut to shape. For lighter products, they opted for moulded pulp, similar to the material used for egg boxes. In both cases, the packaging is not only made from recycled products but is also itself recyclable.

As well as making environmental sense, the new packaging has brought the Company estimated cost savings of \$1 million, based on 1991 production volumes.

Roses Are Blooming In Florida!

Cyril Catt is one of our members enjoying retirement in the sun, in Miami, Florida. There Cyril has become involved in a very rewarding project helping the pupils at an inner-city school of 1,200 12-14 year-olds create their own rose garden.

Cyril began work with a special science class of six 12-13 year-old boys. A bed was prepared, a nursery visited to buy 12 bushes, the bushes planted and each boy made responsible for two of them. Three 20-minute periods each week are devoted to watering, fertilising and spraying and the big moment comes each Friday when the students are allowed to cut the blooms and dispose of them as they wish.

After the first three weeks of the project, a party of girls demanded to know why only boys were involved, so another similar bed was created by six 12-13 year-old girls selected from the group of 20 or more clamouring to join.

At the beginning there was some unauthorised picking of the



blooms, not surprising perhaps when most of the pupils had probably never seen a rose before. A notice was placed beside each bed, "Please do not pick the roses".

Unauthorised picking decreased to one or two - still disappointing for the student who cared for the bush. So "Ask!" was added to the notice.

No unauthorised picking occurred that week and, on the next Friday cutting day, Cyril found between 40 and 50 students awaiting his arrival! It has been a similar story ever since, with the demand always greater than the supply. As Cyril says, "The expressions on faces when given a rose is well worth the effort involved!"

HEALTHWISE

Dr John Goodger, who is a retired company doctor and has spoken on health issues at some of the Company's pre-retirement seminars, continues this new series of articles with a look at exercise.



Never too late to get fit!

Wasn't it Oscar Wilde who remarked "If I think about taking exercise, I lie down until the feeling goes away"? Look what happened to him! Who knows, a few brisk walks and a cold shower or two and he might not have ended up in Reading Gaol! Well, not so soon anyway!

Regular exercise is of undoubted benefit to health. Even more so to that feeling of "well-being" so often regarded as synonymous with youth. Whatever our age, we can all take advantage of fitness routines, provided they're tailored to our personal requirements. And that's the important bit.

Passive exercise

This can be done in bed! Or at least sitting on the bed or standing nearby. Passive exercise means putting all your joints through a full range of movements, without discomfort. Stretching helps. These simple exercises maintain suppleness.

Dynamic exercise

There is good evidence that regular active exercise helps to maintain the blood supply to the heart and protect against coronary disease. But there's no need to push it beyond the equivalent of a brisk walk and a degree of breathlessness.

Here are some ideas:

- If you took regular exercise before retirement, keep to the same activity, modified, as you get older. You are already in training.
- Walking is good for you ... and inexpensive. Begin with short distances and build up in measured increments.
 Aim at a steady two-mile walk each day.
- Swimming has a lot to recommend it. A 10-stone person weighs only 10 pounds in the water and the support that you get from the water sustains joints whilst exercising muscles. The heart rate is increased. But don't get competitive ... swim, exercise and relax, all at the same time. Most pools offer concessions to retired people.
- Jogging is fine if you have been doing it for some time and know your limits. But think about a mini-health screen from your GP to check on blood pressure etc. Not recommended for would-be "beginners" in retirement.
- Cycling is appropriate, if paced and gradual, but don't get run over! Try an exercise bike with adjustable resistance if you can afford one.
- "Keep fit" groups can be helpful provided that you don't overdo things trying to keep up with the class.

Take it steadily

The important thing is to choose a form of exercise you can manage and enjoy. There's no need to go all out; there should be no distress factor. Aim for a regular and disciplined commitment.



MONEYWISE

It was Benjamin Franklin who said "In this world nothing can be said to be certain, except death and taxes". But, even if you can't avoid taxes altogether, it certainly makes sense to check that you're not paying more than you need to. In the following article, **Peter Stimpson**, a divisional director of the Towry Law Group which assists with pre-retirement financial counselling within Rank Xerox, gives some timely advice on tax-saving in the wake of last month's Budget.

ARE YOU PAYING TOO MUCH TAX?

Although new rules on separate taxation were introduced in April 1990, very many people seem not to have taken the changes on board and, as a consequence, they may be paying more tax than they need to.

Separate taxation

The fact is that, under the separate taxation rules, every person with income has a personal tax allowance. So, if you are married, you need to make sure that you utilise both allowances. For example, if a husband has a pension of £7,500 and building society interest of £2,000 a year, whilst his wife simply has the State Basic Pension of £31.25 a week. then the husband ought to transfer his building society savings to his wife. The total of her pension and the building society interest she will then receive will still be less than her tax-free allowance of £4,200 (assuming she is aged between 65 and 74 - see table). So, by completing green form R85, available from all banks and building societies, she will be able to receive the interest free of tax and the couple will reduce their tax bill.

The age allowance trap

Taking advantage of the separate taxation rules may also help you overcome the age allowance trap. The age allowances are withdrawn if your income from all sources

exceeeds £14,200 (£13,500 before last month's Budget) at the rate of £1 for each £2 in excess until your personal allowance reaches the normal basic figure of £3,445. This means that the benefit of the age allowance will run out at £15,710 for over-65's and at £16,050 for over-75's. The effect of this loss of allowance is to tax a band of income between £14,200 and £15,710 (over-65's) or £16,050 (over-75's) at $37^{1}/2\%$ - even though your total income is below the higher rate threshold.

What can you do about it?

If you are a married man whose investment income pushes your total income over the limit and your wife's total income is well below £14,200, then transfer as much of your capital as possible to your wife.

If you are single or married but unable to benefit from such a switch, then consider investing in Investment Bonds and other types of investment which produce income that is not taken into the reckoning for age allowance purposes.

Budget changes

In his Budget last month, the Chancellor proposed reducing the rate of tax on the first £2,000 of taxable income to 20% and increased personal allowances for all age groups in line with inflation. For the under-65's, the Married Couple's allowance stays at £1,720 but, for the over-65's, the agerelated Married Couple's allowance increases (see table). The level at which higher-rate is payable on taxable income, after deduction of allowances, remains at £23,700.

Norman Harris wonders whether through the Newsletter we can unearth any surplus application software packages for his 820 word processor, which he finds has certain limitations. "The responsibilities of Trustees are, on behalf of the members and completely independent of the parent company, to hold the assets and distribute the benefits of the Pension Scheme, in strict compliance with the terms of the Trust Deed and Rules. At our quarterly management meetings, our Secretary, Tony Phillips, acts as professional adviser to the Trustees on legal and procedural matters and also gives a report on general developments since the last meeting. The Investment Manager, David Harris, comments on the overall investment position. Discretionary matters such as ill-health early retirement pensions are then discussed and decisions taken, with medical advice available if required. The meetings usually end with a presentation by an investment house handling a specific sector of our funds.
