From Tony Phillips, Xerox Pensions Manager ...

"As we come to the end of another year, it gives me great pleasure to wish all members of our Pensioners' Association a very merry Christmas and a Happy New Year. I know that all of my colleagues at Xerox Pensions also join me in these seasonal greetings.

Our new name, Xerox Pensions, comes as a direct

consequence of the recent sale by the Rank Group of its remaining interest in Rank Xerox Limited to Xerox Corporation, following which the word 'Rank' is being removed from all company names. A number of pensioners have expressed concern about this change in ownership but I can assure you that you will not be affected by it in any material way and that your pension will continue to be paid as normal. We are discussing with The Rank Organisation whether it will be able to continue offering discounts to members of the Pensioners' Association and we shall let you know the outcome of this in due course.

We have also received a number of enquiries recently about the Chancellor's July Budget, which abolished the tax credits enjoyed by pension schemes on their UK dividend income. Although all pension schemes will be affected by this change, it should not be a cause of concern to you as pensioners, since your pension and the annual increases you receive will not be affected. You can relax in the knowledge that your benefits are quite secure.

I hope, therefore, that you can look forward to the New Year with confidence and that you will continue to enjoy the events, activities and services which the Pensioners' Association offers. I am always grateful to have this opportunity to thank all those people who contribute to the Association's success.

The hard-working team includes Barbara Keech, XPA Secretary; Lois Dawson, who handles the Xerox Pensions end of things; our Regional Co-ordinators, who play a vital role in liaison and administration; and our team of Visitors, who represent the Association on the ground. Thanks to them for all their efforts and best wishes for another good year ahead!"

From 1st November, the word "Rank" has been removed from all Rank Xerox company names and hence our name now becomes Xerox Pensioners' Association (XPA). All documentation is being amended to reflect the name changes and will carry these new logos.



A TASTE OF FRANCE DINARD Thursday 4th June - Wednesday 10th June

Come and join us for an early summer break in the beautiful town of Dinard, on France's Britanny coast. We shall be staying in the Hotel Printania, only a few yards from the beach on the Moonlight Promenade overlooking the harbour. The break will be five nights' half-board accommodation including bed, breakfast and evening meal. Rooms are furnished in period style, with private facilities and French and British TV channels. Staff are dressed in traditional costume and the restaurant, with its panoramic views, serves excellent fish and seafood specialities.

The cost of the holiday is £225, which includes return ferry fare and cabin fee (outward journey only), hotel accommodation, the services of a guide during our stay, and coach, boat and water-bus fares for the various activities described. Single rooms are available at a supplement of £50. The cost assumes an exchange rate of FF10 to £1 - any significant movement in the exchange rate (up or down) might necessitate an adjustment to the price. Travel insurance can be arranged for approximately £17 per person.

We shall leave on 4th June, taking the overnight ferry from Portsmouth to St. Malo, which departs at 20.30 and arrives at 08.30 the next morning.




GARDEN VISIT

Scottish pensioners relive exhibition buzz!



In a novel partnership, current Xerox employees invited exemployees to take part in Scottish Docuworld, the biggest exhibition the Company has ever mounted north of the border. The Xerox pensioners were invited to "turn up and be sociable!" Perfect!

The task was to help with stewarding - greeting visitors, telling them where to go and generally making them feel welcome. No pressure, or at least not much. While putting their experience to work for the benefit of the Company, the pensioners had the chance to renew old friendships.

Private health - cutting premiums down to size

In his July Budget, the Chancellor abolished the tax relief on private medical insurance previously enjoyed by around half a million people over the age of 60. This means that premiums will increase unless you consider various options which may reduce them.

If you have an existing private medical insurance policy, it will continue to benefit from tax relief at the basic rate until it falls due for renewal. But new policies or those renewed after the Budget will not qualify for tax relief.

Premiums for the over-60's had already been rising rapidly, with many older people upset at what they considered to be unfair increases relating to age. With the end of tax relief, the effective rise in premiums will be 30% or more. However, many insurers are working on alternative options for clients with the aim of minimising increases. Here are some which you may want to consider:

- Agree an excess whereby you pay the first amount of each claim. Typically, a £100 excess will reduce your premium by 5-15%. Some insurers offer a range of discounts for higher excesses.
- Pay your premium annually in advance. This could reduce your payments by 5-11%.
- Look at schemes which concentrate on core benefits for in-patient and out-patient treatment and ignore those with unnecessary frills. The lower-cost plans tend to be those which offer only in-
- patient treatment, leaving you to pay for out-patient consultations, physiotherapy and tests yourself or obtain them via the NHS.
- Opt for a more restrictive choice of hospitals. Ask your insurer for details of the hospital list if you are unsure which ones are covered under your policy.

 Seek advice on the best policy to suit your particular circumstances and needs from an adviser with experience in this area see the section on The Private Health

This firm of specialist insurance intermediaries can give you impartial advice about the right private health care scheme for you. For a flat-rate fee, currently £11.75, PHP will send you a questionnaire to fill in and,

based on the information you supply, will then provide you with several quotes at varying prices offering different levels of cover. WARNING: It may be worth "shopping around" to find the best private health deal but do make sure before you switch that any previous illnesses covered under the old policy will still be covered by the new one and that you won't be penalised for them.

Although all policies renewed before Budget Day (2nd July 1997) continue to enjoy tax relief until their next renewal date, you could lose your tax relief immediately if you make any change to your policy which affects your premiums, for example adding a dependant to your registration or switching to another insurer.

Brian Mattinsley looks back on an enjoyable XPA visit to Edinburgh and the Scottish borders in August where forty pensioners, friends and family enjoyed excellent weather, a fine hotel, good company and some of the delights which Scotland can offer.

"After a leisurely breakfast on our first full day in the Park Hotel in Peebles, we boarded the coach for a tour of the Border country with our own local guide. First stop Traquair House, where the famous Bear Gates, last opened 250 years ago when Bonnie Prince Charlie left to pursue the British throne, still bar the drive to the house. They will remain shut until the Stuarts have the throne. As my wife commented, 'It'll take more than a squirt of WD40 to get them open again!'

Next stop was Melrose for lunch and a tour of the Abbey (I'm still struggling with the figure of a pig playing bagpipes!) Then on to Abbotsford House, built by Sir Walter Scott from the success of his writing. He also collected enthusiastically - weapons, instruments of torture, and things African. But the real joy was the house itself. Extended each time the revenue from another book

flowed in, the house is large but still retains a consistent style and harmony.

Saturday saw us in Edinburgh for a guided tour of the city in the morning and free time in the afternoon to do whatever we pleased, which included walking the Royal Mile, visiting Holyrood House and sampling the shops. We arrived just before the Tattoo and the atmosphere was tangible. Street entertainers engaged the crowd: fire-eaters, tightropewalkers, comedians and, on every street corner, pipers. What a

build-up for the evening to come!

Tattoo can mean many things. What we were about to see was not a decoration of the skin! This was the rhythmic tapping which signals the call for troops to return to their quarters for the evening. The Edinburgh Tattoo did more than this. It summoned huge crowds to converge on the Castle Esplanade. Seven thousand of us sat shoulder to shoulder as the evening sky silhouetted the battlements. The lights came up and the scene burst into an extravaganza of sound and colour. The massed Pipes and Drums led the way for a variety of displays from crisp New Zealand marching girls to a lively Caribbean steel band; from realistic military manoeuvres to energetic Highland dancing. The emotion built to the magic of the lone piper high on the Castle playing the lament. This was an evening to remember and, I suspect, more than a few had tears in their eyes."

1997 BUDGET UPDATE

Jack Bonney, Taxation and State Benefits specialist, has prepared this summary of the main changes announced in New Labour's first Budget in July, particularly as they affect pensioners.

The Chancellor kept to his pre-election promise not to change tax rates and personal allowances were also left at the levels proposed by the previous Chancellor in November 1996.

However, this Budget was less than generous to pensioners and pensions in the following areas:

Abolition of tax credits for pension schemes

The impact of this on pension schemes will be severe and widely felt. When a company pays a dividend, it deducts 20% tax and pays 80% to the shareholder. Previously pension schemes were able to re-claim this tax from the Inland Revenue. Now they can no longer do so.

It has been estimated that this could reduce the total income of all pension schemes and other pension providers by £3,500 million in a full year, between 71/2% and 10% of their total income. Robert Maxwell only

plundered £400 million and that was a one-off!

However, as Xerox Pensions Manager, **Tony Phillips**, says on the front page, Xerox pensioners currently in receipt of their Company pension *will not be adversely affected in any way*.

Pensioners though who, after retirement, have created their own business and are investing in a further personal pension, will feel the pinch. If you are in this situation, you will need to increase your contributions by at least 10% to maintain your potential pension at the same level.

VAT on domestic fuel and power

The rate has been reduced from 8% to 5% from 1st September 1997. Age Concern estimates this to be worth 22p a week to the average pensioner – how will we spend it?!

Abolition of tax relief on private medical insurance

This will mean an increase in premiums and pensioners may want to consider cheaper options (see page 5 for more on this).

 The next Budget will be delivered in the Spring.

Beautiful Boppard

The recent XPA visit to the Rhine Valley proved to be a super holiday, reports **Ken Kingham**, who picks out the highlights of the tour in the following account.

After a convenient overnight stop in south-east Holland and a few hours the next day exploring Cologne, we arrived at Boppard in time for a riverside stroll in the sun before joining up for a welcoming drink and dinner in Hotel Ebertor.

The next day, we travelled by coach through the picturesque Moselle Valley to the old town of Cochem. There we enjoyed a wine-tasting session, where we were able to sample several local varieties and undertake a guided tour. This showed us how much planning and dedication goes into tending the vines on the

extraordinarily steep riverside slopes.

Throughout our visit, we enjoyed the magnificent scenery of the Rhine Valley and all its castles and other interesting buildings. While we relaxed in the coach, **Henk Schrijver**, our tour guide and fellow XPA member, filled us in on the local history, including the story of the Loreley which we had the pleasure of visiting on a clear sunny afternoon.

As well as exploring the wider area, we were also happy to enjoy the activities which Boppard itself was able to offer. These included taking a chair-lift to a vantage-point overlooking the greatest bend in the Rhine. 'Vierseenblick', at the top of the chair-lift, means 'Four Lakes View', so called

because the eye sees the river divided into four 'lakes' with the rest being hidden in the folds of the steep valley.

Dinner was usually taken in the open air on the riverside terrace, accompanied by excellent beer and wine and much conversation. There was usually time for an evening stroll along the two-mile long promenade, where luxury house-boats would often moor for the night.

Alternatively, one could visit the nearby hostelries or take a restful drink in the hotel's Kloster-Keller.

GUIDE DOGS FOR THE BLIND ...

the joys of being a Puppy Walker



Following his retirement from Work Control in Bristol, **John Adamson** has taken on the rewarding job of puppy walking, the vital first step in training guide dogs for the blind.

"After the initial euphoria of early retirement, I began to think seriously about how to fill my time. Purely by chance, I heard of a scheme called 'puppy walking for the blind' and, since both I and my wife, **Audrey**, are keen on dogs, I found out more.

Having been approved for the job we could hardly wait for the arrival of our first puppy. Dogs used for this work are usually labradors, golden retrievers, German shepherds (alsatians) and collies. All the dogs are bred at the Guide Dogs for the Blind Association's breeding kennels at Leamington Spa and number some 2,500-3,000 puppies a year. They are 'whelped' by people like us, known as 'brood bitch holders'. The large number of puppies required reflects the fact that a blind dog owner only has a working dog for eight years before it is retired and replaced by another.

Your puppy is placed with you at around 6½ weeks old, having already been vaccinated, so that you are able to get him out on the lead immediately. You need to go for short walks first, to get him used to sights and sounds. Make him socialise as much as possible and constantly correct his behaviour, so that he builds up confidence.

Training then progresses to larger towns and into city traffic, shopping complexes, lifts and stairways. Your puppy will graduate to wearing the coveted blue and yellow coat, which proudly denotes 'guide dog puppy in training'. This tells him that, when the coat is on, he is working. When removed at the end of the session, he can revert to being a hooligan at home!

We keep each puppy until around 10-11 months old when he goes on to the Exeter centre for another 11 months' training.

Then he is matched with his new owner. We are now helping to train our fourth puppy and, along the way, we have also fostered six others for short periods covering holidays or sickness. Of course, it is really sad when a puppy leaves ... but we often meet up with them again at the Association's open days. They never forget you!"


