Pension Increases April 2014

Xerox Pensioners' Timeline

Each year, you receive a pensions newsletter called 'Timeline'. It provides news about pension developments. This year, to provide you with the most up to date information the Timeline will be published in the Autumn.

Tax Codes and Change of Details

We experience a large volume of calls each year in relation to new Tax Codes. Please note, your new Tax Code issued by HMRC is for use in the new UK tax year which always commences on the 6th April. The first pension paid in the new tax year is on the 1st May 2014. The April pension payment is made prior to the 6th April and is the last payment of the 2013/14 tax year.

If you think your tax code is wrong, you should contact HMRC on 0300 200 3300. The Payroll Team cannot advise you on your personal taxation matters.

The website also contains useful forms found under 'Scheme Forms' which include change of personal details. This form can be used for notifying us of a change in your bank account, address and marital status. For security reasons, none of these changes can be notified over the telephone.
