

## THINKING ABOUT HOLIDAYS?



Once Christmas is behind us, it will be time to start planning next year's holidays. At RXPA, we can offer a choice of holidays to suit different tastes and budgets.

#### PALM SPRINGS 8th-22nd April

Something completely different for those who like to travel further afield - 14 nights at the Riviera Resort Hotel in Palm Springs, California. Set in 24 acres of beautifully landscaped grounds with a magnificent mountain backdrop, the hotel offers two outdoor pools, whirlpool, putting, tennis courts, croquet and a health club. A courtesy bus runs all day to the centre of Palm Springs, two miles away, from where guided tours are available on foot, horseback, bicycle or off-road vehicle.

The holiday will cost £781 per person. Insurance, if required, will be £58 and the single room supplement is £196. The price includes 14 nights' bed and continental breakfast. All rooms have either two double beds or a kingsize; private bath, shower and WC; and TV, radio and telephone. As a special deal for RXPA, the price also covers a city tour and an excursion on the aerial tramway, with lunch or dinner.

The hotel has two restaurants, for which vouchers can be purchased at a cost of £56 for seven meals, including beer or wine.

## TEE-OFF IN SCOTLAND 27th-30th May

Although designed with golfers in mind, this tour will also provide an opportunity for non-golfers to enjoy the stunning beauty of Tayside. Accommodation will be at the 5-crown Swallow Hotel just outside Dundee, formerly a baronial hall, which stands in its own grounds and has full leisure facilities. All rooms are en-suite and have satellite TV, telephone and tea and coffee-making facilities.

Golf has been booked at Carnoustie and two other courses, all within 30 minutes drive from the hotel. Excursions will be arranged for the non-golfers at a small extra charge.

The cost of the trip – for bed, breakfast and dinner – will be £279 a head for golfers and £169 a head for nongolfers. The single room supplement is £45. This price does not include travel as it was assumed that most people would make their own way to the hotel. However coach transport could be arranged from a suitable point if there was enough interest.

#### VISIT TO THE BORDERS AND EDINBURGH TATTOO 7th-10th August

Our three nights' accommodation for this visit will be at the Park Hotel, Peebles, about 23 miles south of Edinburgh. All rooms are ensuite, with TV, telephone and tea and coffeemaking facilities. Board arrangements will be bed, full Scottish breakfast, and evening meal with a choice of menu. Guests are able to use the leisure facilities at the Hydro Hotel.

We shall spend a day in Edinburgh, starting with a guided tour, followed by shopping in Princes Street or a visit to Holyrood House, and

rounded off by a visit to the Tattoo on the ramparts of the Castle. Other excursions will include a guided tour of The Borders, taking in Melrose Abbey and Priorwood Gardens.

The price for the tour, including coach travel, accommodation and excursions as described above, will be £190 per person. A limited number of single rooms are available for a supplement of £15. Insurance, if required, can be arranged at a cost of £6.50 a head.

#### SPRING HOLIDAY IN FRANCE 10th-17th May

This will be a self-catering gîte holiday in the Deux-Sèvres region of France, between the Loire and the Gironde. We are currently in the process of arranging a variety of events for the holiday. Travel will be on Brittany Ferries, from Portsmouth to Caen. It is envisaged that some people may wish to make their own way but, depending on support, we may be able to provide coach travel at a small additional cost, to the village of St. Loup-sur-Thouet, approximately 220 miles due south. ## RETURN VISIT TO THE ISLE OF WIGHT 18th-23rd May

The hotel has comfortable rooms, all en-suite, with TV and tea and coffee-making facilities. There is an indoor swimming pool, with sauna and jacuzzi, and live entertainment each evening in the Starlite ballroom.

During our stay, we hope to visit Shanklin Theatre and a variety of other excursions are being planned to places of interest including Morton Manor & Vineyard and Ventnor Botanic Gardens. The inclusive cost of the holiday will be £175 per person.

### Labour shortage at Chatham!

RXPA visitors at Chatham Dockyard found themselves being roped in to help with the job of rope making during a tour of the Dockyard at the end of October. Money for old rope took on a new meaning as a threestrand rope was fashioned, using a traditional method which has hardly changed since the 440-yard factory was built over 200 years ago. Once the rope was finished, a length was cut off and subjected to a test which required an 800-kilo breaking strain to be applied. #### AUSTRIAN DELIGHT

Thanks to **Vi Kennett** for these memories of a most enjoyable holiday in Austria in September.

"The day after our arrival we travelled to Kaprun, famous for its two dams, the main source of Austria's electricity. After two hairraising rides through tunnels which seemed only just wider than the buses and a ride on an open cable car, we reached the top. Sadly we could see absolutely nothing as fog enveloped the whole area! As we enjoyed some hot refreshments, however, before our eyes, the fog miraculously cleared, the sun came out and we were treated to the most amazing view of snow, mountains, sunshine and the reflection in the dam of the whole panorama.

"Our next trip, the highlight of the tour, was on the High Alpine Road to the Grossglockner Peak (3,798 m), the highest mountain in Austria. A wonderful ride round 39 hairpin bends, with fantastic stops to view the snow-covered terrain, brought us to the top. The fit and able continued up the steps to Kaiser Franz Josefs Hohe (2,369 m) for a view across the glacier to the peak. It was like another world!

## AROUND THE COMPANY



## All eyes on Rank Xerox

This year's Open Golf Championship at Royal Lytham and St. Anne's provided an ideal opportunity for raising awareness of Rank Xerox in the national and international media, not only by promoting the Company's name but also by demonstrating its products.

This was the fourth year that Rank Xerox had been involved with the Championship as one of an elite group of seven official suppliers to the Royal & Ancient, organisers of the event. Through its participation, the Company brought its name in front of millions of people worldwide – and at a fraction of the cost of conventional advertising.

As well as having Rank Xerox banners strategically placed on three tees, the 18th green and the grandstand, the Company had its Showliner – a mobile exhibition unit – sited in a prime

location. It was here that copies of the players' scorecards were made available to the public, using two 5635 copiers. Over the four days of the Championship, the Rank Xerox team produced more than 70,000 scorecards on Company-branded paper and handed out mini golf packs to visitors.

Rank Xerox also produced the Players' Guide, supplied to members of the media. As soon as the qualifying rounds had been completed, information on each of the players was sent from the United States via the Internet, arriving at 10 pm. Using a Xerox "Documents on Demand" and a Docuprint, the information was formatted, printed, finished and bound and copies of the 160-page guide were delivered to the Press Office by 3 pm the next day.



### CRATE EXPECTATIONS

Time was when delivery of a brand new Rank Xerox copier meant struggling with the cardboard box it was packed in ... and all the associated corrugated strips, wood blocks, polystyrene mouldings, bubble wrap, sticky tape and wire staples! Well, all that's now a thing of the past.

Two years of dedicated activity by a Quality Improvement Team, led by **Bill Starkey** and representing all the key activities within the Manufacturing & Supply Chain, have led to a breakthrough

in delivery. In future, Rank Xerox copiers will be travelling first class – in the world's most advanced TOTEs (Transportation Optimisation Tools for Equipment).

The Team has produced two designs of re-useable TOTEs, wooden for desktop copiers and steel for




convenience and workgroup machines, with quick-release catches for the sides and tops. Once the new machine is unpacked, the old one can be returned in the same TOTE or, if no machine is being returned, the TOTE collapses to a flat-pack for return to the manufacturing plant. No tools are required to palletise or de-palletise machines; everything the customer needs is in the TOTE. The two new TOTEs will replace the 27 different pack types currently being used for copiers produced at the Mitcheldean and Venray

factories and will offer a saving over conventional packing after only 10 cycles.

The innovative TOTEs are attracting worldwide interest and the Team's achievement has already been recognised by a Xerox Excellence Award and the 1996 Earthday Award.





#### A GREAT DAY OUT!

It was fun all the way at the Open Day held in July to celebrate Mitcheldean's 40th anniversary, which was attended by over 4,000 visitors. A lot of hard work by a committee of dedicated organisers and over 120 volunteers lay behind a day of events as varied as a massive barbecue for all the guests, a Document Technology Centre tour, a vintage vehicle show, Punch and Judy, and computerised magic carpet rides, not to mention running the production lines on Saturday afternoon!

## **New sales strategy**

In a Company-wide initiative, Rank Xerox is starting to use database technology and the telephone to increase the productivity of its sales people. Whereas previously a salesperson could expect to make two or three personal visits a day to customers, he or she can now contact 15 people every day by telephone.

It would be a mistake, however, to assume that this is simply telemarketing or telesales. It is part of a "total coverage strategy", which also includes advertising, direct mail, events and personal visits to

customers. Personal visits may be less frequent but they still play an important part in maintaining a rapport with customers.

Darren Cassidy, who heads the sales team in Birmingham, explains the benefits of the new approach: "It is a different way of working from traditional direct sales but one that people adapt to very quickly when they realise the benefits. Developing the database is extremely important – for each account we now know when and what they will be buying for the next 18 months so we can tailor a

marketing programme to that individual account. That is a highly efficient way of selling."

Most customers are very supportive of this new way of working because they understand what the Company is trying to achieve. Major accounts in particular appreciate the increased efficiency and saving in time which this approach gives them. The process seems to be working well in both large mature markets and in developing markets.

#### **VOTE OF APPROVAL**

Rank Xerox Uganda played a key role in the smooth running of that country's recent Presidential and Parliamentary elections. Working to extremely tight deadlines, the Ugandan team supplied, installed and maintained six Xerox 5385 copiers in the Electoral Commission offices in Kampala to copy the electoral registers for the entire country. At the peak of activity, more than 3 million copies were produced in a single week.

Formally thanking Ugandan General Manager, **Mark Ntege**, for "the great role Rank Xerox played", Stephen Akabway, Chairman of the Uganda Interim Electoral Commission, said that "without your prompt delivery .. the exercise would have been extremely trying".

## Tour Down Under

**Les Farley**, who used to work at Welwyn, sent us this account of his recent visit to Australia and New Zealand with his wife, **Lucy**.

"Always keen on a bargain, we chose Air New Zealand which offered two free nights in Los Angeles. This gave us a great opportunity to visit old El Segundo colleagues, who treated us to their usual hospitality and found us suitably cultural attractions to visit -the Paul Getty Museum and the Huntingdon Library.

"In Sydney we started our tour at the top of Centre Point Tower, the highest in the Southern Hemisphere, which gives stunning views of the harbour and most of the city. Next came a ferry trip to see the Bridge and the Opera House from below. Yet another ferry took us to the Zoo, where volunteer guides introduced us to the amazingly different indigenous Australian animals.

"Cairns, our next stop, is the centre for both the tropical rain forests and the Barrier Reef. The new, completely silent, Sky-Rail traverses about 7 km of forest canopy, allowing enchanting closeups of its day-to-day life. The barrier reef merits as much time as possible. The Inner Reef is a half-

day trip, the Outer Reef is less spoilt but takes a full day.

"Everyone visits Ayers Rock and, once there, you can see why. To see its colours at

their best, tours are made at sunrise and sunset. The purpose-built resort, deep in the desert, is horribly expensive but there is little choice as the next nearest town, Alice Springs, is a four-hour drive away.

"So to New Zealand where, in Auckland, we hired a motor-home, the best way to see the country –



there are cheaper ways but none with so much freedom. Sadly, we had only enough time to get to Rotorua to view the boiling mud and

steam geysers before returning via the East Coast to see the beaches and the National Park beside the Thames Valley. Lack of time meant that we missed the best of the countryside – South Island – so we must return!"



## **MONEYWISE**

#### **More on Self Assessment**



As well as the move to Self Assessment, the self-employed also face a second major change, namely a shift in the basis for tax from the previous year's to the current year's

Earnings from self-employment are normally taxed under Schedule D and, until now, the basis for tax has been the profit earned in the previous year. In other words, the tax for 1995/96 was based on the profit made in the tax year 1994/95. With the advent of Self Assessment, the basis of tax will be the *current* year's profit. For the first full year of Self Assessment (1997/98), the base will be the profit earned in the business year ending between 6th April 1997 and 5th April 1998.

The present tax year 1996/97 is a transitional year and, to achieve the changeover, the tax base will be half the profit earned in the business year ending in tax year 1995/96 plus half the profit earned in the business year ending in tax year 1996/97.

#### Payment of tax

Although the basis for tax will change, the dates for paying the tax will remain roughly the same. The tax for 1996/97 will be paid in two instalments on:

#### 31st January 1997

#### **31st July 1997**

As the first instalment is due before the end of the tax year and so, for many, before the earnings are known, these instalments will each be calculated as half the tax paid in 1995/96. When the true earnings are known, there will be a balancing charge or refund on 31st January 1998. Also on that date, the first instalment of the next tax year's tax will become due

#### Capital allowances

As the tax base for 1996/97 is half of the profits for two business years, the treatment of capital allowances in this transitional year will be as follows:

- Take the written-down balance of assets at the end of year 1994/95.
- Add the value of assets purchased in the 24 months to the end of the year 1996/97.
- Take 25% of the resulting figure to claim against 1996/97 tax.

The reason for these changes, we are told, is to SIMPLIFY the tax system. I suspect that many members will conclude that Self Assessment is to simplification what Mount Vesuvius was to urban development.

## Death Benefits

Tony Phillips, Rank Xerox Pensions Manager, writes:

We find many pensioners asking us whether their widow or widower will receive a pension when they die. The answer is YES. Your widow or widower will receive a pension of one-half of your full pension at the date of your death, including any increases awarded since you retired and ignoring any reduction made if you took a cash sum at retirement. The pension will be reduced if your widow or widower is more than 10 years younger than you and increased if she or he is more than 10 years older but, whatever the circumstances, the minimum pension payable is £250.08 a year. The pension will continue for life, regardless of whether re-marriage takes place.

Pensions are also payable to any dependent children, including step-children and adopted children. These pensions will normally continue until age 18 or until age 21 if the child is in full-time education or training,

## TRUSTEE DIRECTOR ELECTION

All widows', widowers', children's and dependants' pensions are increased in April each year in line with the rise in the Retail Prices Index over the previous year, up to a maximum of 5%. If inflation exceeds 5%, the Company and the Trustee Directors aim to match this figure, although this cannot be guaranteed.

If you die within five years of retirement, your dependants or beneficiaries will receive a tax-free lump sum equal to the unpaid balance of five years' pension payments at the rate prevailing at the date of your death. Certain other lump sum benefits may also be payable, depending on your age and the date you retired.

This range of benefits reflects the continuing security provided by the Scheme for your dependants.
